The above figures are reflective of the median monthly income earned under the Mannatech Compensation Plan (the "Plan") by Mannatech's independent distributors ("Associates") for the period beginning January 1, 2024, through December 31, 2024. This includes the earnings for all Mannatech Associates regardless of rank and PPV qualifications (as further defined below). Mannatech operates on a fiscal calendar year. As of December 31, 2024, Mannatech had a total of 17,257 Associates in the United States. This number includes Associates who didn't earn any commissions or bonuses in 2024. Of that 17,257, there were 14,361 Associates who did not earn commissions or bonuses in 2024. There were 2,061 new Associates who joined Mannatech in 2024. These numbers do not include customers as they do not earn commissions or otherwise participate in the Plan.

All income is earned on the sale of Mannatech products. No commissions, bonuses, or incentive awards are paid or received solely from recruiting or sponsoring other Associates into the Plan and no earnings are guaranteed for mere participation in the Plan.

The figures in the above chart do not include any retail profit that an Associate may earn from selling Mannatech products to others. Associates must supply sales receipts to all retail customers and must maintain copies of sales receipts for at least two years. The figures in the above charts do not include expenses incurred by Associates in the operation and promotion of their Mannatech business. These expenses vary from Associate to Associate. By way of example, these expenses may include product samples, training, rent, travel expenses, telephone and Internet costs, and other business-related expenses. In 2024, the cost to sign up as an Associate was \$49.99. For 2025, the cost will remain at \$49.99 and includes access to digital tools for your business. In 2024, the fee to renew your Mannatech account was \$49.99. Currently, Mannatech is in the process of implementing a new back-office system and is reviewing the renewal process and fees. Therefore, there may be changes to this fee announced later in 2025. You are not required to purchase products when you enroll as an Associate, nor are you required to hold or maintain any inventory while you're an Associate. If you purchase Mannatech products for resale to your customers or purchase products for use in demonstrations to your customers, then the cost of those products would be part of your expenses in operating your business. Mannatech offers product and sales training, launches new products, and hosts recognition functions at various events throughout the year. In 2024, Mannatech held regional events with ticket prices to attend ranging from \$0 to \$49.00 (exclusive of any travel related expenses).

With respect to tools for analyzing and managing your Mannatech business, Mannatech offered a free trial for your first 90 days of our proprietary business management system in 2024. Thereafter, subscription options ranged from \$0.00 to \$15.00 per month. As noted above, Mannatech is implementing a new back-office system. Currently, there are no additional fees for the business management system; however, this could change later in 2025 or in 2026.

In 2024 and through May 2025, Mannatech offered a program authorizing Associates to engage in online paid search engine advertising using Mannatech's trademarks and branding. The initial cost to participate in this program was \$249.00 and \$149.00 each year to renew. This program is no longer available.

As your business develops, you may be eligible for certain tax benefits related to operating a home-based business. You may need to consult with tax or other business advisors for advice.
